

Acceptable Use Policy

CanGlory Education's (referenced herein as "CanGlory") Acceptable Use Policy rules and guidelines (referenced herein as "AUP guidelines") cover and govern each individual end user's (referenced herein with "you" or with "your") use and access to CanGlory's services and websites (referenced herein as the "Service"). CanGlory's Privacy Policy explains how or whether CanGlory (referenced herein with "we", "our" and "us") collects and uses your personally identifiable information.

By using our Service, you are agreeing to use the Service in accordance with these AUP guidelines, and to review CanGlory's Privacy Policy. Please also note that these AUP guidelines and the Privacy Policy are subject to change. Please review the applicable current versions on our website.

If you do not agree to be bound by these AUP guidelines or disagree with the personally identifiable information collection and use practices, you should and may not access or use the Service.

1. License Grant

These AUP Guidelines provide to you a personal, revocable, limited, non-exclusive, and non-transferable license to use the Service conditioned upon your continued compliance with these AUP Guidelines. CanGlory reserves all rights not granted in the AUP Guidelines.

2. Client Restrictions
